## RIGHT-OF-WAY EASEMENT

In consideration of the sum of money hereinafter set out and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned, owner of the premises described as, a correctly grants to the undersigned, the right and interest herein, to use, occupy, enter upon, and do all things necessary, a right of way, easement or otherwise, granted, created, retained, or reserved, or any part thereof, in and upon the property described below,

to plant, grow, trim trees, shrubs, bushes and vines;  
to cultivate land and acre, trees, shrubs, bushes, including orchard and vegetable plots;  
to dig, mine, remove, excavate, underground cables and wires;  
and other similar objects, fixtures, structures or devices.

Upon over and under a strip of land 10 - feet wide across the following lots in Greenville, S. C. generally described as follows: A 10' strip of land on the West side along the Route shown on sketch shown on reverse side as described in Greenville County property plats as Lot 5.17 Block 2 Page 280 on the South east by Century Drive; on the North east by Century Plaza Drive; on the West by Lot 16 Block 2 Page 123.2 and on the South west by Lot 1 Block 1 Page 123.3.

and, to the full extent of the undersigned has the power to grant, to plant, grow, cultivate and under the roads, streets or highways, sitting in the air, so long as.

The following rights are also granted: to use at any other period or occasion, to extend areas to be cleared, to build within the right of way, communications or electrical power transmission, telephone, telegraph and express facilities and premises as and when need to clear the land and keep it cleared of all trees, undergrowth or other constructions within the easement area; to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or branches outside of the easement area which might interfere with or damage the lines or systems of power lines, gas lines, telephone lines or water lines or distribution.

To have and to hold the above granted easement unto Century Drive Telephone and Telegraph Company, Inc. successors and assigns forever.
