AFFIDAVIT

I, Thomas J. Eskew, being duly sworn, do hereby state that I am the son of Charles C. Eskew and Ella Tarrant Eskew, and currently reside at Route 2, Box 20, Piedmont, South Carolina. By review of information contained in the family Bible, my personal knowledge of events and happenings, examination of tombstones, and review of deeds and legal documents on record at the Greenville County Court House, do hereby provide the following information:

Samuel A. Garrison and Nancy Garrison were man and wife. Samuel A. Garrison died July 26, 1858, survived by his wife and four (4) children, John Barksdale Garrison, James Augustus Garrison, Ann Elizabeth Rosman Garrison, and Joel Charles Garrison. Two (2) other children were previously deceased (George Mostetler Garrison, born August 5, 1855, died July 17, 1858 and Maria Alberta Garrison, who was born October 24, 1854 and died July 26, 1858).

Upon remarriage to W. W. Tarrant, Nancy Garrison Tarrant then had two (2) children, Henry Walter Tarrant and Ella Tarrant.

W. W. Tarrant died prior to 1892; Nancy Garrison Tarrant died January 27, 1892; John Barksdale Garrison was born October 26, 1846 and died May 6, 1908 without children, leaving a wife Kate, who died in 1913 testate, leaving all property to a niece, Ellen Eskew; James Augustus Garrison was born May 25, 1849 and died March 10, 1918, never having married; Ann Elizabeth Rosman Garrison was born June 11, 1853 and died January 14, 1891, never having married; Joel Charles Garrison was born April 5, 1851 and died November 22, 1881, never having been married.

Henry Walter Tarrant married Eve Potts. Henry Walter Tarrant died in 1891, and Eve Potts Tarrant died November 9, 1895. This couple left two (2) children, W. H. Tarrant and Grady Tarrant. Grady Tarrant died November 22, 1910 intestate and unmarried, leaving W. H. Tarrant, his brother, as sole heir.

In 1920, suit was brought by Ellen Eskew and W. H. Tarrant for partition. A consent decree was entered (Judgment Roll 7913) which conveyed the one-eighth (1/8) share of Ellen Eskew and the one-fourth (1/4) share of W. H. Tarrant to Ella Tarrant Eskew in approximately thirty seven and one-half (37 1/2) acres on the Greenville-Pelzer Highway, Grove Township, the same property originally
