All that piece, parcel or tract of land in Highland Township, County of Greenville, State of South Carolina located in the New Pleasant Community on the Northern side of Jordan Road and being shown and designated as Tract Number ONE (1) on plat of the Mrs. Pearl Stokes Estate, made by Wolfe & Huskey, Inc., Engineering and Surveying, dated October 18, 1974 and having the following courses and distances, to wit:

Beginning in Jordan Road at a nail and stopper, corner of George W.
