Beginning at an iron pin on the east side of South Carolina Road 50, thence N. 87-35 E. 405.6 feet to an iron pin; thence S. 2-37 E. 107.2 feet to an iron pin; thence N. 87-35 E. 134.55 feet to an iron pin; thence N. 86-14 E. 888.7 feet to an iron pin; thence N. 8-26 E. 237.2 feet to an iron pin; thence S. 85-52 W. 1228.2 feet to an iron pin, thence S. 88.00 W. 235 feet to an iron pin on said South Carolina Road 50; thence S. 3-11 W. 112.2 feet to the point of beginning, containing 6.50 acres.
