TOGETHER with a right-of-way and easement over the property of the Grantor from Highway 11, being a 20 foot access easement from Highway 11 and described as follows:

BEGINAING at a point on the Northern side of Highway 11 and running thence N. 10-17 W. 307 feet to a point, which point is 86 feet North 79-41 W. from an iron pin of the first course and distance described hereinabove; thence N. 79-41 E. 20 feet to a point; thence S. 10-17 E. 307 feet to a point on the Northern side of Highway 11; thence with the North side of S. C. Highway 11 20 feet, more or less, to the point of beginning.
