ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the eastern side of McDade Avenue, in Greenville Township, near the City of Greenville, being shown and designated as Lot No. 104, Block B, City View, on plat prepared by W. A. Adams, recorded March 18, 1911, in Plat Book "A" at Page 461, and having the following metes and bounds to wit:

BEGINNING at an iron pin on the east side of McDade Avenue, front corner of Lot No. 103, which pin is N. 1/2 E. 150 feet from the intersection of McDade Avenue and Morgan Street (formerly O'Neal Street), and running thence with line of Lot No. 103, S. 89-1/2 E. 150 feet to an iron pin on a 10 foot alley; thence with said alley, N. 1/2 E. 50 feet to an iron pin, rear corner of Lot No. 105; thence with line of said lot N. 89-1/2 W. 150 feet to an iron pin on the east side of McDade Avenue; thence with the east side of said Avenue, S. 1/2 W. 50 feet to the point of BEGINNING.

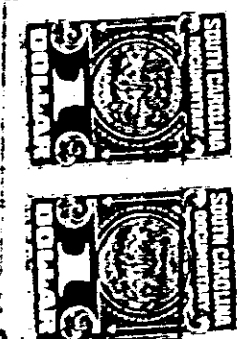
