All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 69 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D, pages 1-5 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Sassafras Drive at the joint front corner of Lots 69 and 70 and running thence with the joint line of said lots, N. 35-18 W. 203.86 feet to an iron pin in the line of a Duke Power Company right-of-way; thence with said right-of-way, S. 52-56 W. 110 feet to an iron pin on the northeastern side of Whittlin Way; thence with Whittlin Way, S. 36-45 E. 23 feet to an iron pin; thence continuing with Whittlin Way, S. 35-06 E. 155.35 feet to an iron pin at the point where Whittlin Way begins its intersection with Sassafras Drive; thence with said intersection, S. 80-58 E. 34.87 feet to an iron pin on the northern side of Sassafras Drive; thence with said drive, N. 53-12 E. 85 feet to the beginning corner.

This conveyance is subject to restrictions and covenants being recorded in the R. M. C. Office for Greenville County in Deed Vol. 991 at Page 10 as well as any other restrictions, rights-of-way or easements that appear of record, on the plat referred to above or as shown on the premises.
