ALL that piece, parcel or triangular strip of land, situate, lying and being off the northern side of Martin Street (also known as Tampa Street) in Greenville County, South Carolina, being a portion of Lot No. 29, Block A on a Plat recorded in the R M C Office for Greenville County, S.C. in Plat Book A, page 396 and being shown on a more recent Plat of the Property of Ada Starkey and Steven Dale Childers made by Jones Engineering Service dated December 19th, 1974 as having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint rear corners of Lots Numbers 28 and 29 of Block A as shown on Plat Book A, page 396, said iron pin being located N. 8-32 W. (also called for in said Deeds as N. 9-22 W.) 118.1 feet from iron pin at the joint front corners of said lots on Tampa Street, and running thence along the line of Lot Number 27 S.85-12 E. 9 feet to a new point; thence a new line through Lot Number 29 S.0-28 W. 56 feet to a point on the common line of Lots 28 and 29; thence along the line of Lot Number 28, N. 8-32 W. 57.5 feet to the point of beginning.

The above described property is a small rear triangular portion of Lot 29, Block A, conveyed to the Grantor by deed of the Trustees of the Calvary Baptist Church recorded in the R M C Office for Greenville County, S.C. in Deed Book 831, page 91 and is hereby conveyed subject to rights of ways, and easements of public record.
