KNOW ALL MEN BY THESE PRESENTS that MELUSINA R. NAPPER,
also known as LUCY R. NAPPER, in consideration of ten dollars
(\$10.00), receipt of which is hereby acknowledged, has granted,
sold and released, and by these presents does grant, bargain,
sell and release unto DAVID M. NAPPER, and does renounce and
relinquish any right of dower she possesses or may possess, in
the following property:

- 1. All that certain piece, parcel or lot of land
with the buildings and improvements thereon,
lying on the northern side of Stonehedge Drive,
near the City of Greenville, South Carolina,
being known and designated as Lot 61 on a plat
entitled "Foxcroft, Section 1" as recorded in
the RMC Office of Greenville County in Plat
Book 4F, pages 2, 3, and 4 and having according
to said plat the following metes and bounds:

Beginning at an iron pin on the northern side of
Stonehedge Drive, said iron pin being the joint
front corner of Lots 61 and 62, and running thence
with the common line of said lots N 3-49 W 165
feet to an iron pin, the joint rear corner of
lots 61 and 62; thence S 36-11 W 169.9 feet to
an iron pin, the joint rear corner of Lots 60 and
61; thence the common line of said lots S 3-49
E 165 feet to an iron pin on the northern side
of Stonehedge Drive, thence with the northern
side of said Drive N 86-11 E 169.9 feet to an

with the buildings and improvements thereon,
lying and being on the northern side of Hills-
borough Drive, near the City of Greenville,

on a plat entitled "Final Plat Revised, Foxcroft,
Map No. 2, Section II," as recorded in the RMC
Office of Greenville County in Plat Book 4N,
pages 36 and 37, and having according to said
plat the following metes and bounds:

Beginning at an iron pin on the northern side of
Hillsborough Drive, said iron pin being the
joint front corner of Lots 108 and 109 and
running thence with the common line of said
lots N 2-51 E 172.5 feet to an iron pin; the
