BEGINNING at an iron pin at corner of Taylor's lot and running thence N. 16-45 W. 472 feet to iron pin in McGill's line; thence N. 75-00 E. 169 feet to poplar, near spring; thence S. 1-30 W. 217 feet to stake; thence with Boyd's line S. 44-20 E. 323 feet to stake; thence S. 80-00 W. 262.5 feet to the beginning corner.
