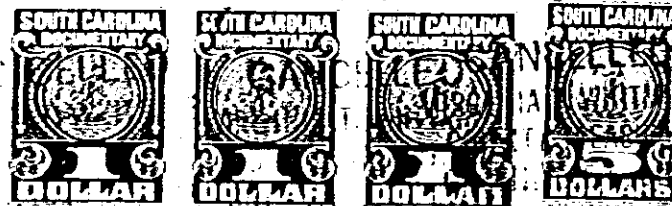
ALL my one-half undivided interest in the following property:
