IN CONSIDERATION for said premises, the purchaser agrees to pay to the Seller a total of twelve thousand eight hundred twenty-four (\$12,824.)-Dollars for said lot(s) as follows: one thousand (\$1,000.00) dollars down and balance of \$11,824.00 to be paid in 144 equal monthly installments of \$134.58 at 9% simple interest. When a total of \$3,000.00 has been paid toward the principal (principal amount is to be computed by adding the \$1,000 down payment and \$2,000 toward principal from the monthly payments [Note that the interest part of monthly payments will not be counted in computing the principality, head is to be granted free of mortgage to the purchasers for two acces. after the date of this contract and will insure all building improvements against loss for the price herein.

In the event any monthly installment is in arrears and unpaid for a period of___45___days, this contract shall, at the option of the Seller, thereupon terminate and any and all payments made by the purchaser prior thereto shall be forfeited by the Purchaser to the Seller as rent for the use of said premises and as liquidated damages for the breach of this contract.

Payments are to begin thirty days from date of closing. Purchasers have the right to prepay any amount at any time without penalty.
