KNOW ALL MEN BY THESE PRESENTS, that We, Larry Moltumyr and Joyce Moltumyr,

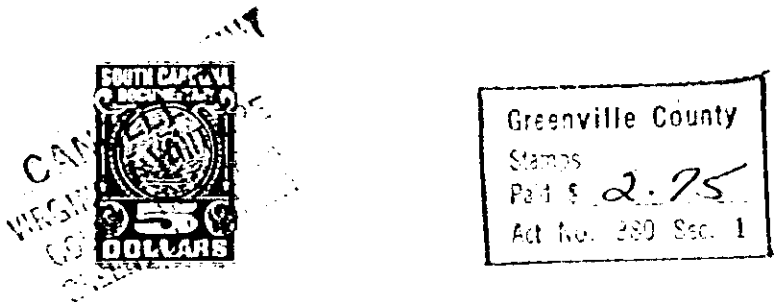
in consideration of Two Thousand and Five Hundred and 00/100 (\$2,500.00) Dollars,

Perry made by W. J. Riddle, Surveyor, dated June, 1946, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "Q", at page 27, reference to which is hereby craved for the metes and bounds thereof.
