duties and responsibilities set forth herein.

- 8. In the event the Trustee conveys any real estate or executes any real estate mortgage, then the owners of at least five-sevenths (5/7ths) of the remainder interests as set forth herein must agree to same and endorse their consent on the mortgages or deed. All of the Grantors herein held a one-seventh (1/7th) remainder interest except Billy M. Woods and Elaine W. Lollis who held a one-fourteenth (1/14th) interest each, and Lois Ila Gilliam, who held a life estate.
- 9. After the death of Lois Ila Gilliam, the Trustee shall be authorized to pay for the expenses of the last illness and the funeral expenses of Lois Ila Gilliam out of the principal or income of this Trust and any other debts or expenses of Lois Ila Gilliam which she, in her discretion, deems appropriate.
- 10. After the death of Lois Ila Gilliam, the Trustee may sell any remaining assets in the Trust and divide the Trust estate as hereafter provided, or she may transfer the title to any property held hereunder back to the beneficiaries hereinafter set forth as she deems appropriate. The Trust Estate shall be divided as follows: One-seventh (1/7th) each to Walter L. Gilliam, Frances G. Coker, Louise G. Ayers, Horace D. Gilliam, Martha G. Kerns and Ruth G. Jones; and One-fourteenth (1/14th) each to Billy M. Woods and Elaine W. Lollis. In the event any of said beneficiaries are deceased at the time of the death of Lois Ila Gilliam, then the deceased's share shall go to his or her child or children, share and share alike, per stirpes. If any should die leaving no child or children, then his or her share shall go to the surviving beneficiaries named herin, per stirpes, according to their respective interests.
- 11. This Trust may be amended or revoked by at least five-sevenths (5/7ths) of the interests set forth in paragraph 10. at any time by the execution of an appropriate document, but same shall not be effective until recorded in the RMC Office for Greenville County, South Carolina. In the event of a revocation, the Trustee would then retain title for the purpose of winding up the trust and making distribution. Any amendment or cancellation shall not require the consent of Lois Ila Gilliam. The purpose of this provision is to permit distribution to the remainder beneficiaries during the life of Lois Ila Gilliam should it be determined that the retention of part or all of the corpus is not necessary or appropriate.
