KNOW ALL MEN BY THESE PRESENTS, that I, James Allen Goethe III

in consideration of one thousand dollars (\$1,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto JULIE MOCODY WESTMORELAND, her heirs and assigns forever

ALL that lot of land in Greenville County, South Carolina, on the south side of Shoals Drive, being near the community of Cleveland, S.C., shown as Lot 4 on a plat of Silver Shoals, recorded in Plat Book MM, at page 35, and according to said plat described as follows:

BEGINNING at an iron pin on the south side of Shoals Dr., at the front corner of Lot 3 and running thence with the line of said lot S.18-00 E 200.7 feet to an iron pin on the northern side of Silver Circle N. 72-15 E 80.02 feet to an iron pin at the corner of Lot 5; thence with the line of said lot N. 18-00W. 189.4 feet to an iron pin on the south side of Shoals Drive; thence with the south side of Shoals Dr., S. 80-16 W 80.9 feet to the beginning.

This being the same lot heretofore conveyed to the Grantor by deed recorded in Deed Book 993 Page 17.

This conveyance is subject to restrictions recorded in Deed Book 548, at page 324, and in Deed Book 608, at page 263.

It is understood that the grantee shall have access and privilege of the use of the Middle Saluda River, together with other property owners purchasing other lots from the grantor herein, with the exception of the river front immediately in front of Lot 33 and West therefrom which is expressly reserved to the Grantor.

This deed is made subject to any restriction and easements that may appear of record, on the recorded plat, or on the premises

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
