dated April, 1969, recorded in the R.M.C. Office for Greenville County in Plat

and distances, to-wit:

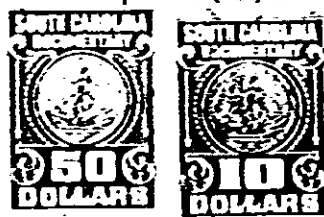
BEGINNING at an iron pin on the eastern side of Candlewood Court at the joint
front corners of Lots 14 and 15 as shown on said plat and running thence with
the common line of said Lots N. 68-27 E. 200.4 feet to an iron pin; thence
S. 14-22 W. 200 feet to an iron pin at the joint rear corners of Lots 13 and 14;
thence with the common line of said lots N. 64-40 E. 140.3 feet to an iron pin
on the eastern side of Candlewood Court; thence with the turn around on the
eastern side of Candlewood Court (the chord of which is N. 8-13 W. 60 feet)
to an iron pin, the point of beginning.
