ALL that piece, parcel or tract of land in Grove Township, Greenville County, State of South Carolina, containing 10.78 acres, more or less, situate, lying and being on Piedmont Avenue Extension in the Town of Piedmont and being more particularly described according to a plat of survey by Dalton & Neves Co., Engineers, dated April 1972 as follows:

BEGINNING at an iron pin on the northern side of Piedmont Avenue Extension at the corner of property heretofore subdivided by Hallman & Propst and running thence N. 13-17 E. 151.3 feet to an iron pin; thence N. 79-43 W. 215.7 feet to an iron pin; thence N. 39-31 W. 193.9 feet to an iron pin; thence S. 13-17 W. 255.2 feet to an iron pin on Piedmont Avenue Extension; thence along Piedmont Avenue Extension S. 22-10 W. 167 feet to an iron pin; thence N. 71-00 W. 80.5 feet more or less, to the Saluda River; thence up the meanders of said Saluda River as the line, the chords being N. 3-28 W. 362.4 feet, N. 12-25 E. 640 feet, and N. 34-11 E. 291.6 feet, to an iron pin at the corner of property now or formerly belonging to Piedmont Water & Light District; thence along the line of Piedmont Water & Light District, S. 34-00 E. 772.5 feet to an iron pin; thence N. 84-03 W. 65 feet to an iron pin; thence S. 81-01 W. 95 feet to an iron pin; thence S. 8-43 E. 396.8 feet to an iron pin; thence N. 79-43 W. 49.2 feet to an iron pin; thence S. 13-17 W. 153.4 feet to an iron pin on the northern side of Piedmont Avenue Extension; thence along Piedmont Avenue Extension N. 76-43 W. 40 feet to the beginning corner.


