in consideration of Two Thousand and Nine Hundred and 00/100 (\$2,900.00) ----- Dollars,

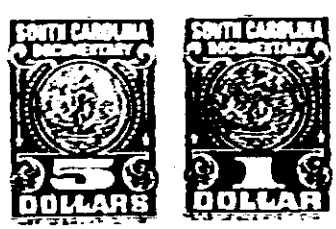
