in consideration of Forty-six Thousand Five Hundred and 00/100 (\$46,500.00)-----Dollars,

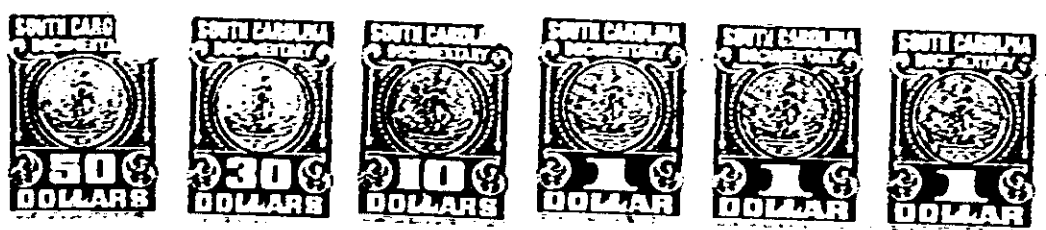
