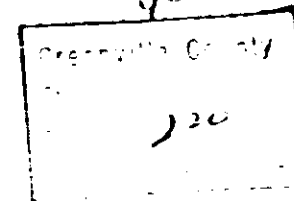
KNOW ALL MEN BY THESE PRESENTS that We, E. C. Howard and Velma Howard
