

KNOW ALL MEN BY THESE PRESENTS, that



in consideration of TWENTY SEVEN THOUSAND FIVE HUNDRED (\$27,500.00) and no/100-- Dollars. AND ASSUMPTION OF MORTGAGE INDEBTEDNESS SET FORTH BELOW: the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIE R. HUDSON, his heirs and assigns forever:

ALL that piece, parcel or lot of land, together with buildings and improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as a portion of Lots Nos. 33 and 34 on a Plat recorded in the RMC Office for Greenville County, South Carolina in Plat Book F, Page 267, and having, according to a more recent Plat entitled "Survey for Willie R. Hudson", prepared by Webb Surveying & Mapping Co., dated September, 1975, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Westerly side of Farr's Bridge Road and running thence along said Road, S. 44-52 E. 84.3 feet to an iron pin at the intersection of Farr's Bridge Road and Eunice Drive; thence along Eunice Drive, S. 50-03 E. 208.4 feet to an iron pin; thence AN. 39-57 W. 60 feet to an iron pin; thence N. 43-15 E. 202.6 feet to the point and place of beginning.

The above described property is the same property conveyed to the Grantor herein by deed recorded in the RMC Office for Greenville County, South Carolina in Deed Book 1007, Page 736, and is hereby conveyed subject to rights of way, easements, conditions, public roads, restrictive covenants and other instruments of public record and actually existing on the ground affecting said property. - 305- 1316-1-8
