












KNOW ALL MEN BY THESE PRESENTS, That We, Thomas L. Wade and Donna P. Wade (now Donna P. Wade Cantrell)

All that certain piece, parcel or lot of land, situate, lying and being on the northwest corner of the intersection of Bessie Avenue and the J. Waymon Smith Road, Pleasant Grove Baptist Church Community, about one mile southward from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being a portion of lot No. 50 of Woodland Heights, property of I. M. Wood Estate, according to a survey and plat by H. S. Brockman, surveyor, dated October 28, 1955, recorded in the R. M. C. Office for Greenville County in Plat Book GG page 151, and having the following metes and bounds according to a more recent plat made for Thomas L. Wade and Donna P.
