the receipt of which is hereby acknowledged, have granted, bargained, sold, and released and by these presents do grant, bargain, sell and release unto CAROL V. ADCOCK, her heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in Butler Township, County of Greenville, State of South Carolina on the southwestern side of Keith Drive, being known and designated as Lot No. 18 and a small portion of Lot No. 27 of Block B in the subdivision of the A. A. Green property according to a plat by Pickell & Pickell, dated November 9, 1945, recorded in the R.M.C. Office for Greenville County in Plat Book M, Page 145, and having, according to said plat, the following metes and bounds, to-wit:
