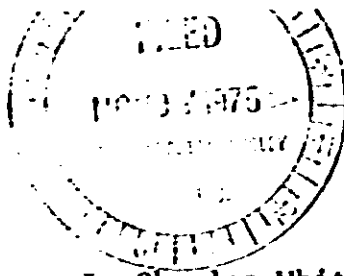

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State Of South Carolina, being known and designated as Lot No. 66, Section 1, Peace Haven, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book VV, Page 83, and having, according to said plat, the following metes and bounds, to-wit:
