Beginning at an iron pin at the rear joint corner of Lots Nos. 7 & 8; thence with a new line through the planting strip N. 37-02 W. 30 feet more or less to a point; thence N. 52-58 E. 53 feet to a point; thence with a new line through the planting strip S. 37-02 E. 30 feet more or less to an iron pin, the rear joint corner of Lots Nos. 8 & 9; thence with the rear line of lot No. 8, S. 52-58 W. 53 feet to the beginning corner.

This is a portion of the property conveyed to G. Dewey Oxner and W. W. Wilkins by Jessie D. Webster by deed dated Sept. 28, 1954 recorded in the RMC Office for Greenville County in deed vol. 509 at page 122. G. Dewey Oxner subsequently died testate, his will being probated and filed in Apartment 781 file 25 of the Probate Court for Greenville County and Frances R. Oxner was appointed Executor-Trustee of his estate with full power and authority to sell and convey real estate.
