KNOW ALL MEN BY THESE PRESENTS, that I, R. H. Bussemey, Sr.

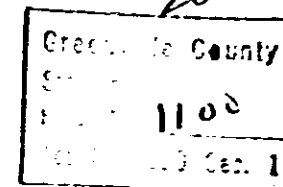
in consideration of Ten Thousand (\$10,000.00) Dollars,
