TO HAVE AND TO HOLD, all and singular the said premises unto the said The South Carolina National Bank, its successors and assigns forever.

And we the said Robert J. Davies and LaMese K. Davies do hereby bind ourselves, and our heirs and assigns to warrant and forever defend all and singular the said premises unto the said The South Carolina National Bank, its successors and assigns, from and against ourselves and our heirs and assigns and from any person whomsoever lawfully claiming, or to claim the same or any part thereof.
