release unto Wayne K. Jones, his heirs and assigns, forever:

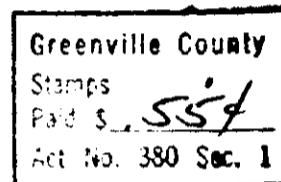
