

Real Property Agreement

In consideration of such loans and indebtedness as shall be made by or become due to Bankers Trust of South Carolina. N.A. (hereinafter referred to as Bank.) to or from the undersigned jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree.

- 1. To pay, prior to becoming delinquent, at taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below, and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selving, assigning or in any manner disposing of the real property described below, or any interest therein, or any leases, rents or funds rield under escribe agreement relating to said premises, and
- In the property referred to by this agreement is described as follows. All that Piece, parcel or lot of land being known as Lot 260 of Section II, Del Norte Estates lying on the eastern side of Ellesmere Drive, as shown on a plat of Section II of Del Norte prepared by Piedmont Engineers, Architects and Planners on record in Plat Book 4N, at pages 12 and 13 in the R.M.C. Office for Greenville County, S.C. and being more fully described by reference to said plat as follows:

 BEGINNING at an iron pin at the joint front corner of Lots 260 & 261 and running thence along the line of Lot 261 S. 46-30 E. 128 feet to an iron pin; thence S. 43-30 W. 95 feet to an iron pin at the joint rear corner of Lots 260 & 259; thence N: 48-30 W. 106.4 (see below)

 Institute the made in the performance of any of the terms bereaf or if default be made in any payment of principal or interest on any notes hereof or lettes the signed by the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the bank and agrees that any judge or prisolation may, at chambers or otherwise appoint a receiver of the described premises with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court, but agrees further that the bank shall have no obligation
- 4. That if default be made in the payment of loans and indebtedness hereunder or the performance of any of the terms hereof. Bank, at its election, may decrare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith

to perform or discharge any obligation, duty or liability of the undersigned in connection with the said assignment of rentals and profits

- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank in its discretion may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs legatees, devisees, administrators, executors, successors, and assigns, and inure to the benefit of Bank and its successors, and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
