Partnership to Commissioners of Public Works of the City of Greenville, S. C.",
dated April 19, 1976, attached hereto and made a part hereof for the purpose
of reading, operating, maintainin, replacing and adding to the water meters
and other appurtenances thereto located on the said property of the Grantor.
