All that certain piece, parcel or lot of land lying in the State of South Carolina,
 County of Greenville, Chick Springs Township, on the western side of Tryon
 Street (formerly Jones Road), and being shown as all of Lot No. 1, and the
 northern side of or northern one-half of Lot No. 2, on plat of property made for
 E. A. Burch and W. R. Frier by J. Q. Bruce, Surveyor, dated January 12, 1950,
 and having the following courses and distances:

BEGINNING at the northeast corner of Lot No. 1 on the western side of Tryon Street
 (formerly Jones Road), corner of property formerly of Styles, on old stake, and running
 thence along the western side of Tryon Street, S. 12-52 W. 157 feet to corner of Lot
 No. 2; thence still with the said road, S. 10-22 E. 35 feet to center of Lot No. 2,
 thence a new line through the center of Lot No. 2, S. 79-38 W. 150 feet to a point
 on the line of Lot 17; thence with the line of Lot 17, N. 10-22 W. 131 feet; thence
 along Styles' line, N. 67-19 E. 217.5 feet to the beginning corner.

 claim the same or any part thereof.

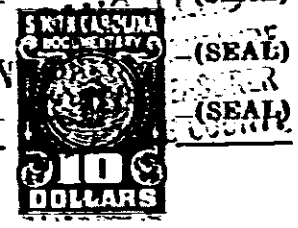
