the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Gerald Denton, Marvin Burrell and George Harris, Trustees, as local Trustees for the Southside Church Of God Of Prophecy in Greenville County, South Carolina, for the use and benefit of the Church Of God Of Prophecy with headquarters at Bible Place, Cleveland, Tennessee, and their successors and assigns, forever:

ALL of that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the eastern side of Odom Circle (formerly Chicora Avenue) near the City of Greenville, being shown as Lot 4 on plat of Riverside, recorded in Plat Book A, at Page 323, and re-copied on plat of Riverside, recorded in Plat Book K at pages 280 and 281, and being more particularly described as follows:

BEGINNING at an iron pin on the eastern side of Odom Circle, at joint front corner of lots 3 and 4, of Block EE, and running thence with the line of lot 3 in an easterly direction 122.5 feet to an iron pin on right-of-way of C & K & W Railroad; thence with said right-of-way 50 feet to an iron pin, corner of lot 5; thence with line of lot 5 in a westerly direction 122.1 feet to an iron pin on Odom Circle; thence with the eastern side of Odom Circle, N. 7-51 W., 50 feet to the point of beginning.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantees' heirs or successors and assigns, forever, in trust, nevertheless, as local Trustees, for the use and benefit of the Church of God of Prophecy, with headquarters at Bible Place, Cleveland, Tennessee, and their successors and assigns forever; provided, however, that neither they nor their successors in office as such local Trustees may sell, convey, or encumber the said real estate without the written consent of the General Trustees of the said Church at Cleveland, Tennessee, which consent may be evidenced by a separate writing or by the Chief Clerk of the said General Trustees joining in the execution of a deed of the above named Trustees or their successors in office for the purpose of certifying the consent of the General Trustees to the execution of such conveyance.
