in consideration of Twenty-One Thousand Nine Hundred and No/100-----(\$21,900.00)-----Dollars,

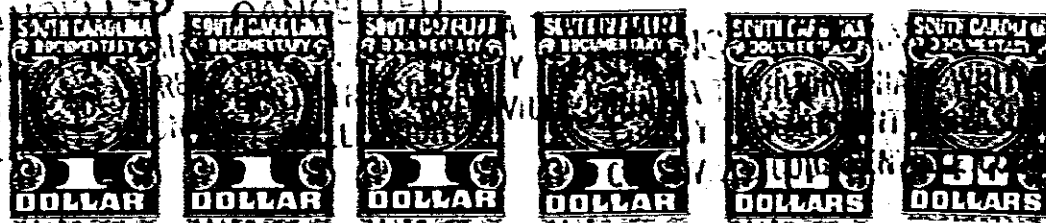
