I, Ione P. Collins,

in consideration of One and No/100-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Betty C. Taylor, her heirs and assigns forever:

All that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid, in O'Neal Township, near waters of South Tiger River, having the following metes and bounds, to-wit:

Beginning at an iron pin in the Mays Bridge Road 24 links from the Misses Sallie and Low Watts line and running thence N. 55 3/4 E. 3.75 to an iron pin; thence S. 73 1/2 E. .43 links to an iron pin; thence N. 75 1/2 E. 7.44 to an iron pin; thence N. 32 1/2 W. 4.86 to an iron pin; thence S. 75 1/2 W. 7.50 to an iron pin; thence S. 55 W. 4.47 to an iron pin; thence along said Mays Bridge Road 4.62 chains to the beginning corner and containing five and ninety-two one hundredths acres (5.92) more or less. This being a part of the old B. F. Goodlett place. — 355-641.2-1-29

Being the same property conveyed to D. A. Collins by I. F. Reese and Minnie A. Reese by deed dated July 22, 1920 and recorded in the R. M. C. Office for Greenville County in Book of Deeds 71, at page 119. Subsequently, D. A. Collins, also known as Dolphus A. Collins, died testate on December 29, 1932, as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 295, File 19. Under the Will of said D. A. Collins, all real estate was devised to his wife, Lula C. Collins during her lifetime and at her death, to his son, Roy A. Collins. Said Lula C. Collins subsequently died and the above described property was owned by R. A. Collins, also known as Roy Abraham Collins, Sr., who died testate on May 13, 1976, as is more fully shown in the Office of the Probate Court for Greenville County in Apartment 1425 at File 3. Under the Will of said R. A. Collins, the above described property was devised to his wife, Ione P. Collins, the grantor herein.
