ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 55 on Plat of Vardry Vale, Section 2, as recorded in the RMC Office for Greenville County in Plat Book WWW at page 53 and shown on a more recent plat entitled "Property of Joseph J. Martin" prepared by Carolina Surveying Co., dated July 13, 1976 and having, according to the more recent plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwesterly side of Vedado Lane at the joint front corner of Lots No. 55 and 56 and running thence along said Vedado Lane, S. 33-59 W., 80 feet to an iron pin at the joint front corner of Lots No. 54 and 55; thence with the joint line of said lots, N. 56-01 W., 150 feet to an iron pin; thence N. 33-59 E., 80 feet to an iron pin at the joint rear corner of Lots No. 55 and 56; thence with the joint line of said lots, S. 56-01 E., 150 feet to an iron pin on the northwesterly side of Vedado Lane, being the point of beginning.
