unto W. C. Cook and Juanita A. Cook, their heirs and assigns forever;

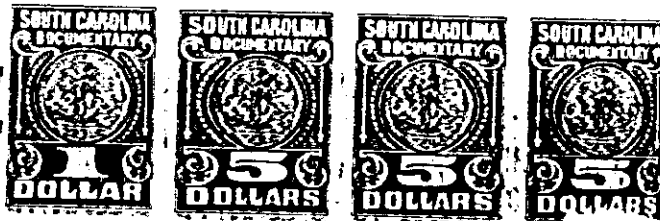
