This Contract made and entered into this 15th day of September.

## WITNESSETH

For and in consideration of the mutual covenants herein expressed and the further consideration of One and No/100 (\$1.00) Dollar by the Purchaser to the Sellers paid, receipt whereof is hereby acknowledged, the Sellers agree to sell and the Purchaser agrees to purchase all that certain land described as follows:
