KNOW ALL MEN BY THESE PRESENTS, that George Chaplin, individually and as Executor of the Estate of Mattie B. Chaplin, deceased

in consideration of division of property in settlement of litigation ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Linda B. Garrison, her heirs and assigns forever, subject however to the life estate as hereinafter set forth:

AN undivided one-fourth (1/4) interest in and to the following described land:

ALL that piece, parcel or tract of land, situate, lying and being on the south-west side of Stevenson Lane, in Gantt Township, in Greenville County, South Carolina, being shown as lot No. 41 on plat of Dixie Farms, made by Dalton and Neves, Engineers, December, 1939, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book L, Page 5, and having, according to said plat, the following metes and bounds, to-wit: BEGINNING at an iron pin on the southwest side of Stevenson Lane at the joint front corner of lots 39 and 41, and running thence along the line of Lot No. 39, S. 18-36 E. 249.7 feet to an iron pin; thence S. 62-05 W. 390 feet to an iron pin; thence N. 75-13 W. 235.7 feet to an iron pin; thence N. 20-10 E. 182.3 feet to an iron pin; thence N. 60-53 E. 410.8 feet to an iron pin in Stevenson Lane; thence with the curve of Stevenson Lane (the chord being S. 80-33 E. 73.5 feet) to an iron pin to the beginning corner.

This conveyance is subject to a life estate in the grantor, George Chaplin, which grantor has reserved for his full use, control, income and possession of the property for and during his natural life. -166-247-5-7 (note)

This is the identical property conveyed to George M. Chaplin by deed of M. W. Fore dated November 21, 1959, which was recorded in the R.M.C. Office for Greenville County on December 23, 1959 in Deed Book 641, at page 214. That by deed dated December 23, 1959 the grantor herein conveyed a 1/2 interest in the above described property to Mattie Lee Chaplin. Mattie B. Chaplin died testate on December 28, 1975, and the within deed is in settlement of litigation, as more fully appears in the records of the Probate Court for Greenville County in File 1407, Apartment 12.
