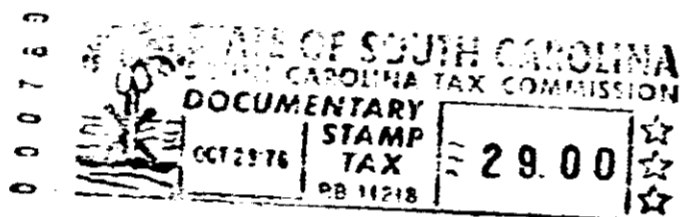
KNOW ALL MEN BY THESE PRESENTS, that HBA PROPERTIES, INC.
