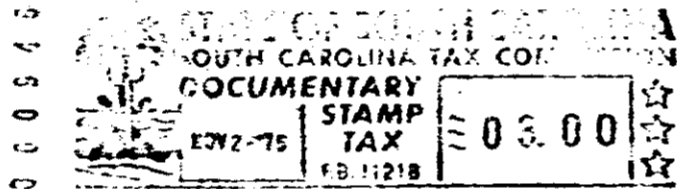
All our undivided two-thirds (2/3rds) interest in and to:
