(Same as Dolan Barrett)

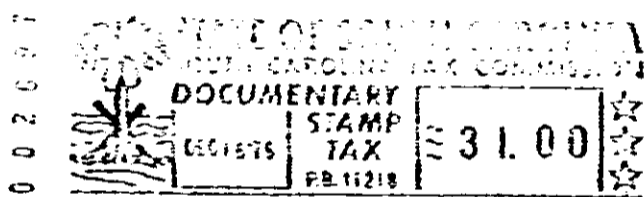
in consideration of Fifteen Thousand Three Hundred Twenty Eight and 64/100 (\$15,328.64)----- Dollars,

ALL that certain piece, parcel or lot of land, situate, lying and being in the State

of a subdivision known as Vista Hills according to a plat thereof recorded in the
FMC Office for Greenville County in Plat Book P, at page 149 and having, according
