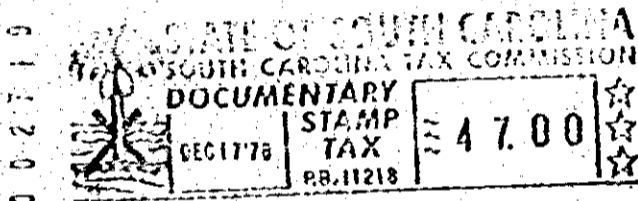

BEGINNING at a point at the joint corner of Units 30 and 31 and thence running S 50-03 E 68.8 feet; thence turning and running S 39-57 W 20.7 feet; thence turning and running N 50-03 W 68.8 feet; thence turning and running N 39-57 E 20.7 feet to the point of Beginning.
