

SCHEDULE AGREENVILLE COUNTY, SOUTH CAROLINA:

All that piece parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the south side of Haynie Street, and being known and designated as Lot No. 5 of Block B of the Chapin Springs Land Company, as shown on plat thereof recorded in the RMC Office for said County in Plat Book A, pages 172 and 173 (revised plat being recorded in Plat Book E, Page 41), and having a frontage of approximately 50 feet on Haynie Street, and running back in parallel lines approximately 150 feet to Pearl Avenue.

Beginning at an iron pin on Washington Loop, joint front corner of Lots 35 and 34, and running thence along the line of Lot No. 35, S. 53-35 W. 153 feet to iron pin at the rear corner of Lot No. 35; thence along the rear line of Lot No. 3, S. 26-35 E. 28 feet to iron pin at the rear corner of Lot No. 33; thence along the line of Lot No. 33, N. 53-35 E. 152 feet to an iron pin on Washington Loop; thence along Washington Loop, N. 31-18 W. 28.2 feet to the beginning.

Beginning at an iron pin 29 feet south of the joint front corner of Lots 35 and 36 and running thence south 57-43 west 153 feet to an iron pin at the joint rear line of Lots 35 and 2; thence with the rear line of Lots 35 and 2, south 26-35 east 22 feet to an iron pin, the joint rear corner of Lots 34 and 35; thence with the joint line of said lots 34 and 35, north 57-43 E. 153 feet to an iron pin on Washington Loop; thence with Washington Loop north 35-52 east 22 feet to the beginning corner.
