I hereby grant and convey a one-thirtieth (1/30) undivided interest in the following described property:

ALL that piece, parcel or lot of land, Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as "Property of I. H. Philpot" according to a survey dated July 2, 1965, prepared by J. C. Hill, licensed Surveyor, according to said survey having the following metes and bounds, to-wit:
