KNOW ALL MEN BY THESE PRESENTS, that I, FLOISE MARPIN

in consideration of Ten dollars and Love and Affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **BERNEST and ERNEST GOLDSMITH**, their heirs and assigns forever;

ALL my interest in that tract or parcel of land containing 63 acres, more or less, situate in Greenville County on the waters of Gilders Creek, beginning at a stake on the M.A. Hunter line, thence N. 74 E. 4.13 to a rock on S.K. White's land; thence along said line, N. 15 W. 13 chains to a rock on the east bank of the long branch; thence up the meanders of said branch to a spring; thence N. 66 W. on Mrs. Kilgore's line to a persimmon 3x; thence on the Kilgore line to a black jack corner; thence S. 20 E. to a stake on M.A. Hunter's line; thence on said line to the beginning corner.

THIS being the same property conveyed to Henry Goldsmith by J.F. Fowler by deed dated November 24, 1887, recorded in the R.M.C. Office for Greenville County in Deed Book TT at Page 595.

ALSO ALL that piece parcel or lot of land containing 4 acres, more or less, lying in the State of South Carolina, County of Greenville, and being more particularly described as commencing at an old corner near the residence of Henry Goldsmith and running thence down the old King White line to a new corner, Nannie H. White line; thence back on her new line to her corner where W.H. Irvine, Henry Goldsmith and Nannie H. White all corner, thence back to commencing corner near Henry Goldsmith's residence.

THIS 4 acre tract describes a triangle, the longest line being the side joining the Nannie H. White line for which a more particular description of this boundary can be found in the deed of Josiah Kilgore to Jessie C. Kilgore, in trust. The 4 acres being a part of the original tract that was deeded to Fannie L. Wood, one of the heirs of Jessie C. Kilgore, the courses and distances of the longest line of the 4 acres may be found on the Nannie H. White line which bounds that land on the east.

THIS being the same property conveyed by deed of Fannie L. Wood to Henry Goldsmith, dated December 2, 1909, and recorded in Volume 9 at Page 561, in the R.M.C. Office for Greenville County, South Carolina.
