THIS DEED, made and executed by J. ELLIOTT WILLIAMS, as United CASES MANAGERY States Marshal for the District of South Carolina, to FEDERAL DEPOSIT INSURANCE CORPORATION, P.O. Box 11510, Columbia, South Carolina 29211.

WHEREAS, Federal Deposit Insurance Corporation, as plaintiff, on or about May 24, 1976, filed its complaint in the United States District Court for the District of South Carolina, Columbia Division against DEVELOPMENT CORPORATION OF AMERICA, as defendant, in Civil Action No.76-919 for the purpose of foreclosing a mortgage encumbering the real property hereinafter described;
