That HARBOR TOWN LIMITED PARTNERSHIP, a S.C. limited partnership hereafter referred to as Grantor, in consideration of the sum of _____ CORRECTIVE DEED _____ DOLLARS, paid to Grantor by Christopher G. and Geraldine C. Trabookis hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee their heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville being shown as Unit 47 on plat of Harbor Town, recorded in the RMC Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 47 and 48 and thence running S 38-30 W, 20.8 feet; thence turning and running N 51-30 W, 68.5 feet; thence turning and running N 38-30 E, 20.8 feet; thence turning and running S 51-30 E 68.5 feet to the point of Beginning.

Shelter Corporation, as general partner, to ratify the act of Horizon Apartments, Ltd. in executing the original of this deed as recorded in Deed Book 1049, Page 844.
