

All that piece, parcel or lot of land in Bates Township, in the County of Greenville, State of South Carolina, near the State Park Road, 1 mile east of Travelers Rest, S. C., reference to which is hereby made for a more particular description, said lot beginning at an iron pin on Batson Road and running thence N 17-20 E. 175 feet to an iron pin; thence running S 74-06 E 194.5 feet to an iron pin; thence running S 15-20 W 200 feet to an iron pin on Azure Avenue; thence running N 74-40 W 173.8 feet to an iron pin; thence running in a curve of Azure Avenue and Batson Road N 28-40 W 34.2 feet to the beginning on Batson Road.
