Foothills Delta P, Inc., its successors and assigns, forever:

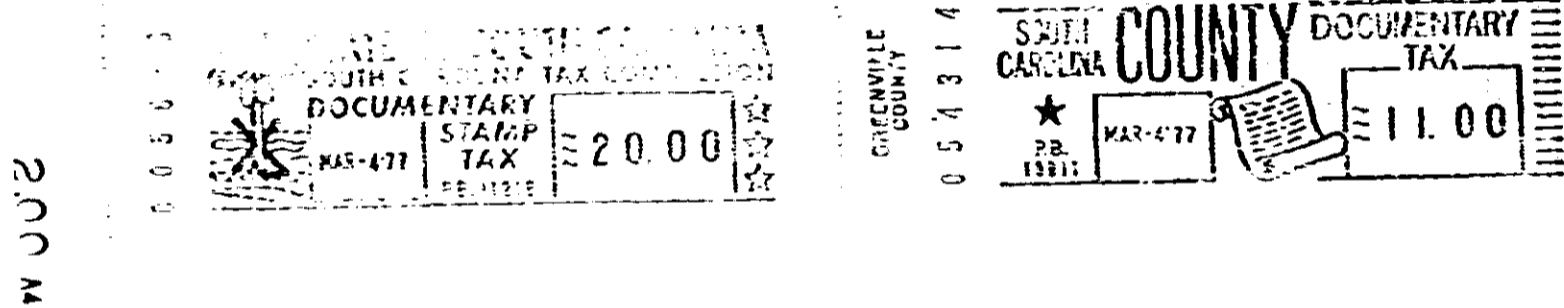
