KNOW ALL MEN BY THESE PRESENTS, that RICHARD A. OWINGS

in consideration of ONE AND NO/100 (\$1.00) ----- Dollars,  
with love and affection

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, by these presents do grant, bargain, sell and release unto

MARY C. OWINGS, her heirs and assigns, forever:

ALL that piece, parcel, or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2, Section B, Oakland Heights, a plat of which is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F, Page 204, and having, according to a plat thereof by Jones Engineering Service, dated March 13, 1972, captioned Estate of L. T. Batson, Jr., the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of West Mountain View Avenue, at the joint front corner of Lots Nos. 1 and 2, which iron pin in S 80-15 E 75 feet from the southeastern intersection of West Mountain View Avenue and Robinson Street and running thence with the southern side of West Mountain View Avenue, S 80-15 E 80 feet to an iron pin at the joint front corner of Lots Nos. 2 and 3; thence with the joint line of said lots, S 9-45 W 170.5 feet to an iron pin on the northern side of an alley; thence with the northern side of said alley, N 80-15 W 80 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the joint line of said lots, N 9-45 E 170.5 feet to the point of beginning.

Together with all the right, title, and interest of the Estate of L. T. Batson, Jr. and of the devisees under the Will of L. T. Batson, Jr., in and to said alley at the rear of and adjoining the said lot, and the interest of the Grantor therein.

Being the same conveyed to the Grantor by deed of Frank P. McGowan, Jr., as Master In Equity for Greenville County, dated April 3, 1972, recorded April 3, 1972 in the R.M.C. Office for this County in Deeds Book 940, Page 45. This deed is to correct the name of the Grantee, shown incorrectly as "Mary A. Owings" in the deed from the Grantor, dated January 7, 1977, recorded that day in the R.M.C. Office for this county in Deeds Book 1049, Page 306.
